



# HOME SHOPPING AGREEMENT

IT IS AGREED that:

1. The Anguilla Postal Service will:

- (a) Rent the attached US Address to the Customer for one year.
- (b) (i) Place in P O Box \_\_\_\_\_ all mail addressed to the customer and delivered to the US Address: or
- (ii) Redirect all mail addressed to the customer and Delivered to the US Address to

- (c) Place invoices reflecting debits to the customer's account in the above P O Box along with items/notices received at the time or direct the invoices and items/notices to the address provided in (b)(ii) above.
- (d) Prepare account statements and place same in the Customer's P O Box or direct same to the address provided in (b)(ii) above, on a half yearly or yearly basis as necessary.
- (e) Place a Notice in the Customer's P O Box advising the Customer that his/her account balance is showing a minimum of EC\$10.00 and of the need to replenish the account, or direct such Notice to the address provided in (b)(ii) above.
- (f) Credit all sums remaining in the Customer's account at the end of the year, to the following year.

2. The Customer will:

- (a) Pay to the Anguilla Postal Service an annual fee of EC \$100.00 for the rental of the US Address.
- (b) Offset conveyance costs by placing a deposit of EC\$100.00 on his/her account with the Anguilla Postal Service, this account will be debited with the relevant freight charges for each imported transaction, as follows:

items prohibited under the laws of Anguilla.**
